### APP

- > We use your data to make the contact, signal and possible follow-up by a professional service provider as smooth and quick as possible. We will use your data for other purposes exclusively with your permission.
- > The app offers the opportunity, to give the people inside your contacts, permission to use your solution



## THE SOLUTION

- > All component inside the ENAI solution collect data and communicate with each other. They share status information. Data exchange does not only happen locally. Data exchange also happens via the Cloud, the app and the affiliated service providers.

## SERVICES

- > We will not sell your personal data to third parties we will exclusively make the data available to the third parties involved with the execution of the services, of to which you yourself gave permission.
- > ENAI data, of which after permission given, you share with third parties fall under the privacy statement of the third party, when the data is in possession of this party.
- > All data ENAI receives of third parties fall under this privacy statement.
- > When you use the cloud services, you give permission to the employees of ENAI and professional service providers to your personal environment when this is necessary for professional services, installation and service related activities.
- > The permission for data exchange with third parties can be revoked at any given time.
